S.O. - 43 In exercise of the powers conferred by sub-section (1) of section 30 of Pharmacy Act, 1948 (Act No.8 of 1948), the Lieutenant Governor of Union Territory of Ladakh, hereby constitutes a State Tribunal to be called as "Ladakh Pharmacy Registration Tribunal" which shall come into force after publication in the Official Gazette of the Union territory of Ladakh.

The Ladakh Pharmacy Registration Tribunal shall be a body consisting of following members, namely, —

1.	Director Health Services, Union territory of Ladakh;	Member
2.	Controlling Authority, Drugs and Food Control Organization, Union territory of Ladakh;	Registrar cum Secretary
3.	Drugs Control Officer, District Leh; and	Member
4.	Drugs Control Officer district Kargil.	Member

The functions, duties and responsibilities of the Ladakh Registration Tribunal shall be as per the procedure prescribed in Pharmacy Act, 1948 (Act No. 8 of 1948).
