S.O.- 42 In exercise of the powers conferred by section 19 of Pharmacy Act, 1948 (Act No.8 of 1948), the Lieutenant Governor of Union territory of Ladakh, hereby constitutes a State Pharmacy Council to be called as the "Ladakh Pharmacy Council".

The "Ladakh Pharmacy Council" shall be a body corporate consisting of the following members, namely, —

1.	Additional Secretary, Health & Medical Education Department, Union territory of Ladakh;	President
2.	Director Health Services, Union territory of Ladakh (ex-officio);	Vice-President
3.	Controlling Authority, Drugs and Food Control Organisation (ex-officio);	Registrar-cum-Secretary
4.	Drugs Control Officer, District Leh;	Member
5.	Drugs Control Officer, District Kargil;	Member
6.	Government Pharmacist, Sub-center Farooana District Kargil;	Member
7.	President, Chemist & Druggist Association, District Leh; and	Member
8.	President, Chemist & Druggist Association, District Kargil.	Member

After the same is published in the Official Gazette, the Council shall initiate process of registration of Pharmacists and, -

- nominate the Government Analyst under the Drugs and Cosmetics Act, 1940 (23 of 1940), *ex officio*, from any of the notified laboratories for Union territory of Ladakh,
- elect 6 members, elected from amongst themselves by registered pharmacists of the Union territory of Ladakh after compilation of registration process, and
- elect one member elected from amongst themselves by Registered Medical Practitioners of Union territory of Ladakh, possessing registration certificate from any notified Medical Council or an elected member from Medical Council, Union territory of Jammu & Kashmir.


